- Controlled Access Documents secured
- Document Management
- Destruction of documents

- → Plans distributed to each company
- Link emailed to contact on NDA

## **PROJECT OVERVIEW**

General Scope of Service and Requirements

The contractor shall provide all work required for complete and functional communications and security systems as indicated on the construction drawings and specifications. This may include, but is not necessarily limited to; Video Storage Nodes, IP Video Cameras, servers, workstations, video management software, uninterruptible power supplies (UPS), wire and cable, conduit, surge suppression, grounding and bonding, supporting enclosures, mounts, and devices, identification, fire stopping, testing, record drawings, installation permits, inspections by governing authorities, cutting and patching work, start-up of systems and equipment, training of Owner's operating staff.
